

# MiCAL and MiDatabank Trainer 2022



**MiCAL** (Medicines Information Computer Aided Learning) is a web-based training package. It is designed to support pharmacy professionals in developing the knowledge and skills they need to answer medicines-related questions in a safe and effective way. It can be used by anyone looking to develop the skills to provide direct medicines management advice to patients and professionals.

MiCAL is a compilation of stand-alone modules and incorporates approved resources and guidance (e.g. [NICE guidance](#)). Pick and choose the areas you and your learners need to complete as and when needed. Guidance on suggested completion profiles can be found in the [User Guide](#). Use the guidance to deliver robust and reproducible training more efficiently across one or more pharmacy sites.

MiCAL can be used by tutors to compliment face-to-face training.

Learn how to:

- Assess medicines-related questions.
- Gather all the necessary information to help you to answer medicines-related questions effectively.
- Effectively use medicines based resources and understand their limitations.
- Find useful literature from Medline and EMBASE searching.
- Critique randomised controlled trials and apply the findings to practice.
- Formulate effective verbal and written responses to medicines-related questions.

### ➤ Clinical tutorials

- A basic refresher on clinical topics ranging from adverse effects to travel health.
- Raise your awareness of factors to consider when dealing with certain topics, e.g. drug administration in children.
- Interactive test-yourself questions throughout.

### ➤ Enquiry answering scenarios

- A variety of simple and complex interactive medicines-related case scenarios to work through and compare your results to good standard answers from medicines information specialists.
- Multiple choice questions pre- and post-scenario to test learning gained through completion of the case.
